



MERRIMACK WATER MAIN EXTENSION PROJECT BRENDA LN

On Wednesday, October 16, 2024, St. Gobain's Contractor, Joseph P Cardillo & Sons, Inc. (Cardillo) will begin work on the Merrimack Water Main Extension Project for ***Brenda Ln. Below are details provided by the Engineering Firm, WSP USA as well as contact information for both WSP USA & Cardillo.***

DETAILS AS PROVIDED BY THE ENGINEERING FIRM, WSP USA

BRENDA LN: Installation of new water main on Brenda Ln will be connected to MVD's existing water main located on Brenda Ln. Cardillo employees (as well as MVD's staff) along with construction equipment will be in the roadway. During the work there will be a temporary interruption in water service for locations on Brenda Ln. Additionally, the work may disturb sediment in the water mains which can cause discolored water as well as air in the service lines; due to this, locations in the area may experience fluctuations of pressure and/or brief interruptions of water service as well as discolored water. Work is scheduled to begin at approximately 8:00 AM. ***Attached are copies of the documents that have been distributed by WSP USA and/or Cardillo.***

Note: Discolored water is typically caused by sediment, such as iron. Although discolored water is not aesthetically pleasing it is not *unsafe and can be easily resolved by flushing the water service line to the property. Flushing allows a larger than normal quantity of water to flow through the service line which helps clear out the sediment. You may notice the discoloration return after the water has sat in the lines for a period of time, such as overnight or during the day if it's not being used - this is to be expected. When the water is not used for a longer period of time the sediment settles, when water is turned on it is agitated and the discoloration returns. If this happens you may repeat the flushing process. If your water is discolored, we recommend avoiding the use of hot water until the cold water is clear. If you have used hot water prior to/during flushing and are noticing discoloration in the hot water, the water heater may need to be flushed - refer to the manufacturer's manual for instructions or contact a licensed plumber. *Some people may be more vulnerable to contaminants in drinking water than the general population. These people should seek advice about from their health care providers.
